Dear Mr. Harland:

In September 2023, the Company and Union created a new Sourcing and Contract Specialist classification series. Due to this agreement, the parties discussed the conversion of the ESC represented Contract Administrator-ESC classification series into the newly created classification series, Sourcing and Contract Specialist.

Pursuant to these discussions, the parties have agreed to the following, effective April 1, 2024:

1. All incumbent Contract Administrator-ESC employees will be reclassified to the appropriate Sourcing and Contract Specialist classification as follows:

- 2. Incumbent Contract Administrator-ESC employee's current salaried wage rate will be moved into the salary wage range for the appropriate Sourcing and Contract Specialist classification.
- In addition, incumbent employees will have their time in the related Contract Administrator-ESC classification counted towards time in their respective Sourcing and Contract Specialist classification for purposes of determining progressive wage increases as described in Title 15.4(b)(2) of the general ESC-PG&E contract.
- 4. Any and all references to Contract Administrator-ESC (50227122) and Contract Administrator, Senior-ESC (50327909) included within the ESC Collective Bargaining Agreement will be deleted.
